

Resolution 2017-74

Amend Increase in Kootenai County Sheriff's Office Fee Schedule see Resolution 2016-95

WHEREAS, Idaho Code §31-3202 vests the Board of County Commissioners with the power and authority to set, by resolution, civil fees to be charged by the Kootenai County Sheriff's Office for various civil services provided by the Sheriff's Office within Kootenai County; and,

WHEREAS, Idaho Code §31-3203 states that the civil fees established shall be reasonable related to but not exceed the actual costs of the civil services provided; and,

WHEREAS, Idaho Code §63-1311A allows for fee increases not to exceed 5% after a properly noticed public hearing has been held; and,

WHEREAS, the Kootenai County Board of County Commissioners adopted Resolution 2016-95 on August 23, 2016, setting the civil fees to be charged by the Kootenai County Sheriff's Office; and,

WHEREAS, legal notice of the proposed civil fee increase was published in the Coeur d'Alene Press, and a public hearing was held on August 23, 2016 as required under Idaho Code §63-1311A; and,

WHEREAS, the State of Idaho Senate Bill 1202 was signed into law on April 6, 2017 and made effective as of July 1, 2017, making charges for commissions only valid for real and personal property sales, thus making number 13 on Exhibit "A" invalid.

NOW THEREFORE, IT IS HEREBY RESOLVED that the fee schedule attached hereto as Exhibit "A" and incorporated herein by reference shall apply to civil services provided by the Kootenai County Sheriff's Office effective as of October 1, 2016, and such fee schedule shall continue in effect for succeeding years, unless changed or modified by formal resolution. Shall now strike the commission fee listed in number 13 retroactive to July 1, 2017.

BE IT FURTHER RESOLVED that Resolution 2017-74 shall supersede Resolution 2016-95.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Fillios, seconded by Commissioner Bingham, the following vote was recorded:


